Para 1.20	The charity has four band sections, main, intermediate preliminary and beginners.  Beginners of any age/ability are recruited throughout the year. As members grow in knowledge and ability they move up to the next band level. The charity was forced to cancel its 2021 Christmas Concert but with the start of 2022 was able to return to more normal activities.  It held public concerts in May, September and December.  The September concert, the bands birthday concert, was attended by Alan Fernie a well-known brass composer. He had been commissioned by the charity to compose a suite of Suffolk Dances. He rehearsed these with the main band, on the morning of the concert, and conducted the first performance of the composition at the Birthday concert. Alan also held workshops in the afternoon for the bands intermediate, preliminary and beginners bands.  In December band members played at local carolling events in Martlesham and Woodbridge collecting donations for three charities nominated by band members. The funds raised will be distributed equally between the three charities next year.  The main band also played in Ipswich at Brass on the Grass in Christchurch Park, at Ipswich Music Day and a Queen's Jubilee celebration service.  They also played at the Suffolk Remembers event in Felixstowe.
